Jeanne Archer, Community Missions Corporation Associate Director for Program Compliance, informed the guests about the safe housing and support services provided to the residents of the two apartment buildings owned and managed by Community Missions. Juda House and St. Joseph's Haven shelter 34 men. The staff works to provide a comprehensive approach to support men whose addictions, mental health, and other barriers have resulted in ongoing homelessness. A tour of the two facilities followed lunch provided by Mr. Goodcents.

A second Lunching and Learning was held on May 15 at Family Guidance Center and included insight into services provided by Family Guidance and The CENTER, a Samaritan Center (two United Way Partner Agencies). The meetings will be taught by volunteer St. Joseph School District teachers and will be held at public library locations throughout the city.

Families who attend all four free meetings will receive school supplies including a backpack for their child.
